Keynote Speech (II)

Mr. Hiroshi Komori

ISSB member International Sustainability Standards Board

Hiroshi Komori was appointed as a member of the International Sustainability Standards Board (ISSB) in August 2022, effective 1 September 2022.

Before joining the ISSB, Mr. Komori served as Senior Director and Head of the Stewardship of the ESG Division at the Government Pension Investment Fund (GPIF) in Japan from 2015 to 2022, where he established the Division and developed GPIF's investor engagement and participation in international sustainability initiatives.

Prior to his work at GPIF, he worked for Sumitomo Mitsui Trust Bank, where he created an investor relations consulting service for Japanese companies and Saitama Bank (now Resona Bank).

Mr. Komori holds a Master's of International Relations from the International University of Japan.

Dr. Yi Hsin (Doris) Wang

Chairperson Accounting Research and Development Foundation

Dr. Yi Hsin (Doris) Wang has served as the Chairperson of the Taiwan Accounting Research and Development Foundation since 2014. Doris Wang is a professor of accounting at National Taipei University, and has been the IIA member for more than 25 years since 1997. She was elected as the Chairperson of the Institute of Internal Auditors-Chinese Taiwan from 2012 to 2016, the Vice Chairperson of IIA-Chinese Taiwan (2008 to 2012), and had been a member of the Board of directors (2012 – 2020). Especially, Doris Wang was a pioneer to introduce the IIA Certification in Risk Management Assurance® (CRMA®) to Taiwan and was the first one to earn the CRMA certification in Taiwan.



Doris Wang has been the keynote speaker for the IIA, ACIIA and IFASS international conferences since 2010. Dr. Wang earned her PhD in Accounting from the University of Kentucky and has the certification of the ISO Lead Assessor (ISO 9002 & ISO14064-1), USA CPA, CIA, CGAP, and CRMA. She had served as a volunteer with the ACIIA, and IIA Global from 2012 to 2020.

Professor Wang has been committed to promoting IFRS, IFRS ISSB, XBRL, COSO, COSO ERM, IPPF and has made outstanding impacts in the accounting profession through research, education, publications, conferences, speaking and activities since 1997. She is the author of many books including COSO Internal Control — Integrated Framework 2013 (Chinese version), COSO Enterprise Risk Management Framework: Integrating with Strategy and Performance 2017 (Chinese version) and other accounting professional books.

Mr. Jamie Allen

Secretary General Asian Corporate Governance Association (ACGA) Hong Kong

Jamie Allen is the founding Secretary General of the Asian Corporate Governance Association (ACGA), an independent membership association carrying out original research, advocacy and education on corporate governance in Asia since 1999. A published author, he has more than 30 years of experience writing about Asian business, finance, and economics. Prior to founding ACGA, he was a consultant providing customised research to multinational companies. From 1992 to 1995, he was editor of Business Asia for the Economist Intelligence Unit and a contributor to The Economist magazine from 1994 to 1996. He is one of the main authors of Awakening Governance: The evolution of corporate governance in China and CG Watch 2020 – Future promise, two reports published by ACGA in July 2018 and May 2021 respectively.



Jamie is the local convenor for the Sustainability and Climate Action Task Force (SCATF) formed in February 2022 by the Financial Reporting Council of Hong Kong.His past public service roles include being a member of the Public Shareholders' Group,formed by the Hong Kong Securities and Futures Commission (SFC), sitting on the Listing Committee of the Stock Exchange of Hong Kong, and serving on the Operations Oversight Committee of the Financial Reporting Council of Hong Kong.

In 2017, he received an International Corporate Governance Network Lifetime Achievement Award and a Regional CG Recognition Award from the Minority Shareholders Watch Group of Malaysia.

He is a graduate of the Australian National University, Canberra, where he received a BA (Hons) in political science and Chinese language. He studied Mandarin Chinese in Taiwan from 1983 to 1984.

Mr. Jesse Chou

Chief Sustainability Officer and Spokesperson, Delta Electronics, Inc.

Mr. Jesse Chou joined Delta Electronics, Inc. in 2004, and currently serves as the chief sustainability officer and spokesperson, responsible for the company's ESG strategy management and stakeholder management. With a comprehensive background in both public relations and ESG, he helps the public fully understand Delta's mission and practices in sustainable operations through two external communications strategies:



Delta as "international corporate citizen" and Delta as "green energy pioneer". From 2009 to 2015, he also served as the secretary of Delta's board of directors, assisting in promoting corporate governance. His achievements as Delta's spokesperson were recognized with the Excellent Spokesperson Award at the 2016 Outstanding Public Relations Awards organized by the Foundation of Public Relations.

In 2005, Mr. Chou led an ESG professional team to complete Delta's first ESG report, and in 2015 Delta committed to the international initiative We Mean Business. In 2017, the Company passed the Science Based Targets initiative (SBTi) review and reached its targets ahead of schedule. Building on the efforts made for the SBTi, Delta took a step further to join the RE100 initiative in 2021 with a commitment to achieving the overall goal of 100% renewable electricity and carbon neutrality by 2030 for all of Delta's global locations. Delta's SBT Net-zero goal also passed the SBTi's review as the first company to do so in Asia's technology hardware and equipment industry.

As a result, Delta has been selected for the Dow Jones Sustainability Indices (DJSI) World for 12 consecutive years since 2011 and achieved the highest overall score in the global electronic equipment industry for 7 years. In 2020 and 2022, Delta was recognized by the CDP with two A List ratings on "climate change" and "water security" issues. Delta has won the top CSR awards held by Common Wealth Magazine and the Global Views Monthly for many years, and it has been recognized with honor rolls.

Mr. Chou received a master's degree from the Institute of Communication Science at National Chiao Tung University. He is currently the vice chairman of the Taipei Neihu Technology Park Development Association and the director of the Center for Corporate Sustainability. Before joining Delta, Mr. Chou served in several prominent companies and organizations including the Industrial Technology Research Institute, Vanguard International Semiconductor Corporation, and Taiwan Semiconductor Manufacturing Company. He has also served as a lecturer at Shih Hsin University's Department of Speech Communication. In 2021, he was awarded the Alumni Role Model of Tunghai University.

Julia is EY's Asia-Pacific Public Policy Leader who is responsible for regulatory and public policy matters across more than 20 countries including Australia, China/Hong Kong/Taiwan, Japan, Korea, and ASEAN. Before joining ACRA in 2009, Julia spent 13 years as an auditor with KPMG Singapore and two years as the Group Vice-President of Corporate Finance & Treasury at a large public listed healthcare company in Singapore.




Keynote Speech (III)

Professor Shibli Rubayat-UI-Islam

IOSCO APRC Vice Chair Chairman, Bangladesh Securities and Exchange Commission

Professor Shibli is currently serving as the Chairman of Bangladesh Security and Exchange Commission – the capital market regulator. He has served as the Dean of the Faculty of Business Studies (4th time elected) and also as the Chairman of Sadharan Bima Corporation (2 terms) - the largest state owned insurance company.



Author of 'E Banking and E-Commerce', 'Fundamentals of Insurance' book for the tertiary level and Finance and Banking text book for the secondary students published by the National Board Professor Shibli has more than 18 research publications in his field, 2 international book chapters and 5 international research papers. He has also been awarded as the 'Guest Professor' at Sichuan University in Chengdu, China and awarded as the best research paper presenter at the BAKU international research conference. All through first class in his academic carrier, he also has research degrees, diploma, and training in the field of Finance and Banking in Australia and Japan. He was also the elected Senator and Syndicate member of University of Dhaka and took care of the Switzerland Bangladesh Chamber of Commerce and Industry (SBCCI) as the Secretary General for consecutive four terms. Member of many other academic and professional selections boards and engaged with many academic institutions-Prof. Shibli was also the elected General Secretary (two times) of Dhaka University Teachers Association (DUTA) and Federation of Bangladesh University Teachers Association (FBUTA) for consecutive two terms after serving other positions like Vice President and Treasurer.

BLF Introduction

The funds under BLF's management include the Labor Pension Fund (the New Fund), the Labor Retirement Fund (the Old Fund), the Labor Insurance Fund, the Employment Insurance Fund, the Arrear Wage Payment Fund, the Occupation Incidents Protection. Moreover, BLF is commissioned to manage the National Pension Insurance Fund and the Farmers' Pension Fund. At the end of June in 2023, the total assets under the Bureau's management stood at about US\$ 204.9 billion. Domestic and overseas investments are about US\$ 92.6 and US\$ 112.3 billion respectively. The asset allocation percentages between domestic and overseas investments are 45.2% and 54.8%.
